

WARRANTY & DISCLAIMER

Protection Technologies, Inc. (PROTECH) WARRANTES ITS PRODUCTS ("Product" or "Products") to conform to its own specifications and to be free of defects in materials and workmanship under normal use for a period of twenty-four (24) months from the date of sale. Within the warranty period, Protection Technologies, Inc. will repair or replace, at its option, all or any part of the warranted Product. PROTECH will not be responsible for dismantling and/or reinstallation charges. To exercise the warranty, the User ("User," "Installer" or "Consumer") must be given a Return Material Authorization ("RMA") number by PROTECH. Details of shipment will be arranged at that time.

This warranty does not apply in cases of improper installation, misuse, failure to follow installation and operating instructions, alteration, abuse, accident or tampering, and repair by anyone other than PROTECH.

The warranty is exclusive and expressly in lieu of all other warranties, obligations or liabilities, whether written, oral, expressed or implied, including any warranty of merchantability or fitness for a particular purpose. PROTECH will not be liable for any consequential or incidental damages for breach of this warranty or any other warranties.

This warranty will not be modified, varied or extended. PROTECH does not authorize any person to act on its behalf to modify, vary or extend this warranty. This warranty will apply to PROTECH Products only. All other products, accessories or attachments used in conjunction with PROTECH equipment, will be covered solely by their own warranty, if any. PROTECH will not be liable for any direct, incidental or consequential damage or loss whatsoever, caused by the malfunction of its Product due to products, accessories, or attachments of other manufacturers used in conjunction with PROTECH Products.
